To ensure that we comply with DEC regulations and facilitate work flow, we have added additional staff and will have more dumpsters on site. Staff at the gate will verify residency and control the flow of traffic.

Please note that all materials must be sorted by metal, wood and trash. If debris includes tires, there will be a \$2.00 charge per tire. *Any appliance with Freon (including air conditioners, refrigerators and freezers) must be accompanied with proof of removal of the Freon by a certified technician.* (For a listing of certified technicians, please refer to the yellow pages listing under "refrigerating equipment".)

The New York State Electronic Equipment Recycling and Reuse Act were signed into law in May, 2010 and took effect on April 1, 2011. This year, we will continue to be able to collect:

Computers, Televisions, small scale servers, computer peripherals (including monitors, keyboards, mice, fax machines, document scanners and printers) as well as small electronic equipment (including VCRs, video records, DVD players, cable or satellite receivers, video game consoles.)

NEWS FROM THE PLANNING BOARD

Current progress on the Master Plan, amendments to the Town's Zoning Ordinance and the Draft Steep Slope Law have been continuous over the last year. Revisions to the Draft Steep Slope Law are being considered to incorporate comments and concerns from many residents, the Canandaigua Watershed Council, the Yates County Planning Board and the Finger Lakes Regional Planning Council drafted the original model law from which municipalities around the lake could work from.

Our current Moratorium of Hydro & Gas Fracking which includes both vertical and horizontal drilling was extended until September. Reviews of current zoning law amendments and an update of our Master Plan include revisions to protect the community from heavy industrial uses once the state lifts its' present Moratorium.

PHASE 1 OF THE TOWN BARN RENOVATION TO BEGIN

Phase I of the Town Barn rebuilding project was awarded on 6/29/13. This part of the project is to install a new roof over the undamaged portion of the facility in preparation for overall remodeling of the structure. Work shall start on or about 7/10. Phase II should be awarded during the week of 7/1. This part of the project will include new exterior metal siding, interior liner panels with insulation and (4) large overhead doors for the northern half of the facility, which will be new, heated truck storage. Within the month of July, three (3) additional bid packages will be prepared and sent out for bids: a new concrete heated floor system, a new boiler and building electrical. It is planned that all the above will be done prior to the end of the year. Included in this scope will be new surface treatments for the office, break room and parts area that sustained smoke damage. The south end of the facility where the fire occurred will likely be demolished this year as well, in preparation for a new two bay truck maintenance section. Budget planning for this final phase is underway at present.

NEWS FROM THE WATER SUPERINTENDENT

Water System Maintenance

As many of you know our main water district is nearly 50 years old. The water mains are made from cement-lined cast iron. These mains are subject to break at any time due to their age. If you should see water coming out of the ground along the roadside please call. I would rather check it out and have it be nothing, rather than be wasted water. If you live near a fire hydrant please consider maintaining the area around it. This is especially important during the winter months with snow. If the area around fire hydrants is debris-free, firefighters will be able to respond more quickly.

NEWS FROM THE CODE ENFORCMENT OFFICER

Contact the Town's Code Office to assist you through all phases of your particular project, keeping you in compliance with current town/state regulations. Most permit applications can be found inside Town Hall or online at <u>www.middlesexny.org</u>. **Regulations to note**:

- Current Pool Regulations now include any structure containing more than 24" of water. This includes: above and on ground pools, spas, hot tubs, and fixed in-place wading pools. All require a minimum 4 ft. barrier that completely surrounds and obstructs access to the body of water. Gates on the barrier must lock securely and be equipped with pool alarms. Contact me with any questions or concerns.
- New York State Property/Maintenance Code allows for ONLY ONE unregistered vehicle on your property. There are several local auto companies that will remove these vehicles for you at no cost. Please contact the Code office for the local list if you require assistance.

NEWS FROM THE ASSESSOR'S OFFICE

The Assessor's office ended another assessment year with the filing of the final assessment roll July 1, 2013. The values on this roll will be used by the Marcus Whitman and Naples School Systems in September 2013, for their tax billing and in January 2014 for the Town of Middlesex and County of Yates tax billing.

Please send me any address corrections as soon as possible. If my addresses are wrong, that could delay the arrival of your tax bills in September and January. You need to remember that it is your responsibility to pay the taxes even if you do not receive a bill. So it is important to keep your address current with us to avoid any problems.

New York State is playing with the STAR program and will be sending post cards to anyone who gets the Basic STAR program. The department of taxation and finance who now controls the State Real Property Office will be requiring you to go online and register with them to ensure that no one is getting more than one STAR exemption. They have also firmed up the requirements for those who reside in more than one state. They will also pull your STAR exemption if you owe the State any income tax money. STAR is only available if Middlesex is you primary residence.

The Assessor's office is looking at doing a 2015 town wide revaluation as we are seeing an increase in sale prices. New York State could change our plans if they press us to do the update for 2014.

My office hours are Wednesday mornings from 9:30 a.m. to Noon and the second and fourth Thursday nights of the month, 6 p.m. to 8 p.m.

NEWS FROM THE MIDDLESEX HERITAGE GROUP

Thanks to our dedicated volunteer historians, the Middlesex Heritage Group will continue to support major programs with the Town of Middlesex. On August 4, we will celebrate the 10th annual Appreciation Day honoring three distinguished citizens. The selection committee has chosen Mary Lafler, Rodney Bassett and Bob DeVinney. Mary and Bob are deceased. They were all long term residents who made significant contributions to the town through their volunteer efforts.

Mary was the Ambulance dispatcher 24 hours a day for many years. Rodney has been and continues to be a dedicated member of the Fire Department. Seneca Heritage Day is a historical and educational event highlighting our long standing relationship with the Native Americans of our area. YATES COUNTY ENHANCES EMERGENCY CELL PHONE NOTIFICATIONS

Yates County Sheriff Ron Spike advises that the Yates County 911 Communications Center utilizes the Hyper-Reach Emergency Notification System as a method for "reverse 911 notifications" for emergency preparedness and other notifications of county-wide residents. The system automatically uses land line telephone numbers provided by telephone companies. However for people who use wireless "cell" phones, or use TDD/TYY, or digital VoIP phone, or a service like Magic Jack then those numbers are not included in the Hyper-Reach agency database and those people are urged to sign up for Hyper-Reach notifications. "The number of people who are dependent on their mobile telephone is increasing every day and 911 dispatchers receive a majority of calls on these devices," said Sheriff Spike, "We also utilize the Nixle system for community advisories via texts and email."

"The Hyper-Reach system has been used in the past by dispatchers for notifications of localized emergencies, hazardous material incidents, barricaded persons, missing persons, criminal activity, and other dangerous conditions in a neighborhood or identified geographical area," said Chief Dispatcher Sandra Smith, "911 Dispatchers can choose an address range or map a geographical municipal area, and send a mass recorded voice message to all telephones in that area very quickly."
