Town Clerk Topics

Thank you to all Town residents for their patience this past year as we have all have had to make changes during the pandemic. Currently the Town Hall is open as usual (see schedules and hours on the front page). We ask that you wear a mask if you have not been vaccinated.

DOG LICENSES - Our local Dog Control Ordinance states: **All dogs over 4 months of age must be licensed.** Please stop by the Clerk's office with a copy of your pet's Rabies Certificate & proof of spay/neuter. Cost is \$10 annually - \$18 for non-spayed/non-neutered dogs.

SIDEWALKS - Town sidewalks need to be accessible to residents at all times. Please refrain from parking on the sidewalk.

ACCESSIBLE PARKING PERMITS - Town residents can get their parking permit anytime during regular office hours. Requirements are listed on the form provided by your doctor.

MARRIAGE LICENSE - Please call the Town Clerk for an appointment. The license fee is \$40.

CODE ENFORCEMENT OFFICE

The Town's Code Office is here to assist you though all phases of your particular project, keeping you in compliance with current town/state regulations. Most permit applications can be found inside the Town Hall or online at www.middlesexny.org. New construction, additions, roofs, decks and excavation all require building permits. **Contact the Code Office at 585-554-3607 BEFORE** starting plans for your project to see if it requires a permit. Please contact this office if you think your property falls within a SSPA (Steep Slope Protection Area) as Steep Slope Regulations are now in effect and require application through this office prior to any excavation or development.

Code Regulations Important to Note:

- Current **Pool Regulations** now include any structure containing more than 24" of water. This includes: above and in-ground pools, spas, hot tubs, and fixed in-place wading pools. All require a minimum 4 ft. barrier that completely surrounds and obstructs access to the body of water. Gates on the barrier must lock securely and be equipped with pool alarms.
- NYS Property/Maintenance Code allows for **ONLY ONE unregistered vehicle** on your property. There are several local auto companies that will remove vehicles at no cost. Please contact the Code Office for the local list if you require assistance. Current Code Office hours are listed on the front page or by appointment.

Middlesex Reading Center

Exciting changes are happening here at the Middlesex Reading Center! The New York State Education Department decided last year that they would no longer support Reading Centers, and therefore, we would also lose our affiliation and support from the Southern Tier Library System. We knew that without that support the Middlesex Reading Center would likely fold. To continue we would need to become a chartered library. We then began the process, beginning with the budget proposition at the Marcus Whitman budget vote held on Tuesday, May 18, 2021. We proposed the new budget that we felt would get us started on the path to becoming chartered. We requested the increased budget of \$40,442 from \$9,997. The voters were supportive and the budget passed. I want to say thank you to everyone who voted yes. This was a one-time increase and future increases will be kept under the tax cap.

The next step in the process is to establish a board of directors for the new Middlesex Municipal Library. We are going to need five to nine people who are willing to serve on this board. If you are interested, please call Sabra Dunton at (585) 554-6945, ext. 1007. Please leave a message if you call at a time that I'm not here. I will need to have the board in place by Labor Day. When we have a complete board, we can then begin the next step.

In order to ensure compliance with DEC regulations and to facilitate work flow, we have added additional staff and we will have more dumpsters on site. Staff at the gate will verify residency and control the flow of traffic.

Please note that all materials must be sorted by metal, wood and trash. If debris includes tires, there will be a \$2.00 charge per tire. Any appliance with Freon (including air conditioners, refrigerators and freezers) must be accompanied with proof of removal of the Freon by a certified technician. (For a list of certified technicians, please refer to the yellow pages listing under "refrigerating equipment.")

The New York State Electronic Equipment Recycling and Reuse Act was signed into law in May 2010 and took effect on April 1, 2011. This year, we will continue to collect:

Computers, Televisions, Small Scale Servers, Computer Peripherals (including monitors, keyboards, mice, fax machines, document scanners and printers) as well as a small electronic equipment (including VCRs, video records, DVD players, cable or satellite receivers, video game consoles).

Materials NOT Accepted — NO EXCEPTIONS!

The following will not be accepted:

- Hazardous waste
- Radioactive waste
- Unapproved industrial, asbestos or medical waste
- Free liquids (i.e. paint must be completely dry)
- Intact steel or plastic drums or liners (must be empty & crushed)
- Intact containers greater than 5 gallon size (must be empty & crushed)
- Materials with less than 20% solids
- Appliances with Freon unless proof of extraction is provided
- Bulk yard waste
- Suspicious or unrecognizable materials
